PRESIDENT'S REPORT

I hope this message finds you all safe, in good health and good spirits.

This past year has been unprecedented on so many levels. From the outbreak of a pandemic and a nation-wide lockdown, through to extraordinary fires here in Australia, protests around racism and inequality, or the largest economic and social crisis our nation has ever experienced.

It has been unprecedented as well in the demands all these overlapping crises have placed upon us all, personally and professionally. Not a day has gone by when we have not been negatively affected by what we experience in our day-to-day lives, what we see on televisions, or what we come across on our social media feeds.

Yet at the same time, one of the things that has given me hope during this period is the many interactions I have had with many of you online, with our team at the Executive Committee and with our many partners. Your positive and enthusiastic responses to the changes that we have had to institute here at the UNAAWA have renewed my sense of optimism, and reinforced our belief that it is more important than ever that we continue to learn and practice solidarity and kindness.

I can say with all honesty my first term as President has been full of trials and surprises. We began the year with a well thought out and exciting timeline for events covering all the major issues we care so much about. From the environment to education, sustainable development through to gender equality, 2020 was going to be a year of renewal with our values and of trying new and intriguing ways of connecting with you all.

However, COVID-19 changed all that. For very good reason, many events were cancelled or postponed to exercise duty of care to our volunteers, members and community supporters. Yet many great ideas were also presented to the Executive Committee to ensure that we could continue to serve your needs, and because of that I am confident that we are already well on the way to forging a stronger and more united UNAAWA.

At the start of my mandate we identified three core pillars which we wanted to further develop. The first was fundraising, to strengthen the reserves of the organization and ensure our ability to operate on your behalf. The second pillar was the reinforcement of our stakeholder engagement and partnerships, which have been a source of success in the past and which have the potential to truly elevate the UNAAWA as a trusted voice for sustainable development in the eyes of the public. Finally, enhanced communication was our third pillar and our best tool to ensure all our members and partners feel connected to our work and see the value in it. On all three points, and despite the difficult circumstances, I believe you'll find that we have delivered and, in some cases, surpassed our expectations.

The shift to online events afforded us the opportunity to engage much more with many of you who might otherwise have been unable to attend our traditional events. Being able to archive many of our webinars, interviews and talks on our Facebook page means that any of you can watch them at a time of your own choosing, and I invite you to do so when you can.

This has led to an increased engagement with our events compared to before, and many of you have told me about the tears you have shed listening to some of our talks, or your sense of hope at realizing that there is a lot we can do to create positive impacts.





Over the past several months, we have interviewed a variety of inspiring figures here in Australia and around the world. We heard from Nyoognar Elder, Ben Taylor AM, on his captivating story of overcoming injustices and gaining hope for Indigenous lives in Australia. On the same subject of discrimination, especially due to the rise of anti-Asian sentiment because of the pandemic, we heard from the Australian Race Discrimination Commissioner Mr Chin Tan on what we can all do to help move towards a more inclusive society in Australia.

Our Series on "COVID-19's Impact in Australia" looked at the impact the pandemic has had in the areas of human rights and gender rights in WA and Australia more broadly. They brought together lawyers, academics and key practitioners to examine the consequences of the pandemic, whether the response has so far been effective, and what can be done moving forward.

In addition, to get a better sense of the impact of the COVID-19 crisis on the world of work, I was pleased to interview a fellow Australian at the International Labour Organization (ILO) in Geneva, Dr Sher Verick, who shared with us the latest data on the labour market and the recommended policies of the ILO to help protect workers worldwide.

Further events on Gender Equality explored gender and leadership, how to support young women in leadership positions, and general information about representation and positions of power. While our SDG Business Forums series on "Business Transformation to Achieve the SDGs" at EY and "Accelerating Innovation & SDGs" brought together local business leaders to share how they take leadership in achieving SDGs and how they have been innovating their way through this crisis.

These are just a sample of the many events that took place online, and as circumstances have improved here in Western Australia we have already begun meeting again in person. From networking events to fundraising events, it has been a relief to see so many of you healthy and well.

I therefore am sure that I speak for all of us in saying that this year's United Nations Day event will be especially special as an opportunity to come together and celebrate the organization we so admire, and an organization that matters so much more in these challenging time. I therefore invite as many of you as possible to join us on the 23rd of October at the Duxton Hotel for the 75th Anniversary of the UN.

In addition, I am proud to announce another milestone; a partnership between the UNAAWA and the Rotary Club of Perth. This partnership will create many new opportunities for both our organisations in networking, volunteering and fundraising, and therefore enable us to expand our social impact in supporting humanitarian causes, peace advocacy and spreading kindness, which is needed more than ever in times of crisis.





FINANCIAL OUTLOOK

In other good news, the reserves of the association continue to grow year on year. The important security of funds in 2020 was made possible thanks to the COVID-19 relief grant won from Lotterywest, combined with implementing several stop-loss and cost containment measures. We expect that the effects of these measures to have long term cost benefits over the foreseeable future.




The net revenue has drastically increased between 2019 and 2020. This is partly due to the success of the fundraising events, amongst others the UN Day and the SDG Business Forums in the last 18 months.

Further, most events held during the year have at a minimum broke even. The net revenue increase is also attributable to the office lease termination and cost reduction measures such as moving to VOIP and virtual offices, taken as a proactive response against the negative economic impacts of COVID-19.

Despite the restrictions imposed by COVID-19 which led to inability to hold physical events between March to August, the strong financial performance of the association prior to the COVID-19 pandemic has allowed the organisation to maintain a stable and solvent status this year and in the next 12 months.







The fundraising income (including grants) has increased by **44%** compared to the 2019 financial year. This improvement is partially attributable to the successful UN Day event held in October 2019, which generated close to \$11,000. The event was partially supported by Lotterywest, which granted the association an amount of \$18,500. This has also been possible thanks to the other fundraising efforts performed throughout the year such as the SDG Business Forums generating a net revenue of close to \$5,000 in the last 18 months


Despite the challenges the pandemic brought to the fundraising landscape, the income stream coming from the membership fees has remained stable in the 2020 financial year.


The donations remain low in 2020 in terms of dollar value; however, the income level has increased by **252%** compared to 2019. We expect that the income generated from donations will increase in the upcoming financial year, as donations can now be made through the association's website (previously donations could only made via National site, bank transfer, cash or cheque).














The distribution of memberships remains consistent with the previous financial year, with the most popular membership category being the ordinary members, followed by the concessional members.

The organisational membership type includes members from the corporate, government, and non-for-profit sectors, as well as universities.

The number of memberships has remained relatively consistent over the years, with a small decrease in 2020.

Despite the Covid-19 pandemic, the Association has been able to maintain a strong membership base by providing member with value through our educational, advocacy and cause promotion work through online events and programs. We've also maintained close ties with members and partners by informing, updating and engaging them through newsletters and holding virtual panels sessions and interviews that are current and relevant to the public's interests.





This past year has also led to many changes in the running of the UNAAWA. Several team leaders have understandably moved on to study commitments and job opportunities, but we have also seen an extraordinary influx of new talents joining us and contributing to our mission with exciting ideas. Our new Human Rights committee, for example, is now the most diverse one in the history of our association.

Finally, I would like to acknowledge that none of the above would have been possible without the tireless work of our many volunteers, sponsors and partners. The UNAAWA is an entirely volunteer-run organization, which nonetheless operates with a degree of professionalism and dedication that makes me proud.

I would therefore like to thank all members of the leadership team in the Executive Committee. Special thanks are extended to Thijs Roos for his dedication and ingenuity in supporting us through this very stressful and transitional time; Camille Doucet for her diligence and meticulous work ethic in keeping us solvent; a warm appreciation to both Katharine McKenzie and Natasha Kusmuk for their enthusiasm and passion in making meaningful connections with our members and stakeholders; Manita Beskow and Joseph Caruso for both their long-serving contribution to this organisation, their guidance and invaluable wisdom during this difficult time; Teresa Lee for doing an amazing job these two years in bringing us and the community the UN Day event, our keystone fundraising event of the year; Jurgen Baumhoff for being relentless and determined in forge an alliance between us and the Rotary Club of Perth. As you will see in the rest of this report, the work of the many sub-committees is exemplary and the result of a truly outstanding level of dedication, commitment and hard work. The values with which everyone at the UNAAWA works with are the very ones the United Nations was set up to encourage, and it has been my honour to serve as your President throughout this year.

We also sincerely appreciate the support of our Parton, the Honourable Kim Beazley AC, Governor of Western Australia for his guidance and continued belief in our organization.

I would like to end with one key message. As we all know, the pandemic is still ravaging parts of our beautiful country, so I urge you all to continue look after yourselves and each other, to stay safe and be kind. There are still many challenging days ahead of us, so now more than ever we need to show compassion and solidarity with our neighbours, with our communities and with all our fellow Australians. For in the words of António Guterres, the Secretary-General of the United Nations, "none of us will be safe until all of us are safe."

STRATEGY & EXTERNAL ENGAGEMENT

What was supposed to be a busy year for UNAAWA had turned into one that is of reflection and renewal of partnerships and relationships. Despite the challenges posed by the pandemic, we have pivot and adapted to using technologies to better understand and engage our internal and external stakeholders.

Stakeholders Engagement & Partnerships – Various forms of engagement have been initiated to support disadvantaged youth and CALD communities in WA. It is essential to continue our advocacy work in promoting diversity, inclusion, justice, community development and education. As such we have continued to connect and engage with the following organisations for the past 12 months: Zonta Club of Perth Inc, WA Police Force Senior Multicultural Women Leaders Advisory Group, the Organisation of African Communities in WA Management Committee, the University of Western Australia Young Alumni Network, the Department of Home Affairs, and the Museum of Freedom and Tolerance. We would also be working closely with the Edmund Rice Centre to bring artworks created by young people of the centre for exhibition and auction at the upcoming UN Day event. Other initiatives that would help develop community leadership with the youth would also been explored.

Communications – We have taken an increasingly active approach through greater engagement with our members and the public during the pandemic via our key social media channels such as the UNAAWA Facebook, reaching 2700 followers to date. We have also revamped our website and digitise content for wider outreach, sharing of knowledge and increasing accessibility of our work to the community. The need to improve our data analytics capability would help better support our membership base and better understand the changing stakeholders and community needs in times of recovery ahead.

Whilst we recognise that there has been drastic challenge in fundraising due to the crisis, it would be important for us to continue elevating UNAAWA's advocacy efforts, forming partnerships with value stakeholders to widen our outreach efforts and join forces with frontline providers so that those most affected by the pandemic are able to gain the support needed for recovery.

2019/2020 UNAAWA Education Reference Group Annual Report

The UNAAWA Education Reference Group advises on the implementation of Kindergarten to Year 12 school programs seeking to empower students (and their communities) to be active global citizens.

1. Global Citizenship Schools Network	Gained 3 new members; however, membership of 19 schools lapsed. Membership at 30 June 2020 = 19 schools Kindergarten to Year 12.
2. Education Resources Bank	Online repository of 21 digital resources maintained. Global Citizenship Education You Tube channel maintained and new resources uploaded.
3. School Speakers	12 speaker engagements focused on the Global Goals with high level of engagement of students and teachers. Two engagements cancelled due to pandemic lockdown.
4. Student Parliaments	6 April <i>Primary Student Parliament</i> (7 schools, 40 students, 6 teachers) and 8 April <i>Secondary Student Parliament</i> (8 schools, 48 students, 9 teachers) cancelled due to pandemic lockdown.
5. Sustainability (Global Goals) Challenge	Education for Sustainable Development (ESD) through challenge-based learning. Showcasing students thinking globally/acting locally to advance the SDGs. Eight schools (4 primary and 4 secondary) involved in 2019. Winners: Coolbinia Primary School and Shenton College (Aleena Flack, Olivia Donati, Harry Brauhart for Lifeline).
6. Yolande Frank Art Awards	Human Rights Education through visual arts. 49 entries from 15 schools over 3 categories (2018 = 52 entries from 17 schools). Finalists' works displayed at Peace Day event and included in fundraising calendar. Winners: Years 4-6 James McGinty (Coolbinia PS), Years 7-9 Angus Rorrison (Bold Park CS), Years 10-12 Madison Snelling (Prendiville Catholic College).
7. World Teachers' Day Awards	Showcasing programs advancing Global Citizenship Education. 2019 Winners - Primary: Changing the Way We Think program, Tracey Toovey St Mark's ACS,; Secondary: 5000 Meals and Kinjarling Djinda Ngardak Culinary Experience programs, Catherine MacDougall Cyril Jackson SC.
8. Curriculum Packages	Implementation of the UNAA <i>Global Citizenship and Sustainability</i> WACE-Endorsed Program in 4 schools. Certificates presented and results included on WA Certificate of Education. Professional Learning session (2/12/2019) attracted 17 participants from 10 schools.
9. Partnerships for the Goals	Strategic collaboration advanced with Curtin Learning Futures, One World Centre, Sustainable Schools Alliance WA, Sense of Place Regional Centre of Expertise, WA SDG Network and Valuing Children Initiative. New partnerships negotiated with Project Management Institute, We Are Here!, and Student Edge.





10. Events

Led successful event celebrating International Day of Peace (22 September) including *Partners in Peace Fair* (with 12 other organisations) and *Peace Ceremony* (with Yolande Frank + Sustainability Awards presentations).

Promoted UN and SDGs through events conducted by partner organizations – Mindarie SC + Lynwood SHS Sustainability Expos, Meerilinga Family Fun Day and Carine SHS Future 2040.

UNAAWA Global Goals Challenge: Mainstreaming ESD in Schools recognised as an **Outstanding Flagship Project** by UN University, Regional Centre of Expertise in ESD Hub Tokyo.

Highlights from the fourth year of implementing UNAAWA School Programs seeking to empower our school students to be active global citizens:

- Implementing the UNESCO Framework for Global Citizenship Education by demonstrating how teachers may reframe (rather than reform) the Western Australian curriculum and add value through strengthening the socio-emotional and behavioural domains of student learning.
- Participating in the UNESCO Futures of Education initiative "a global debate on how knowledge, education and learning need to be reimagined in a world of increasing complexity and uncertainty."
- Showcasing and promoting the work of school communities in advancing achievement of the UN 2030
 Sustainable Development Goals and contributing directly to SDG 4 Quality of Education, Target 4.7
 implementing Global Citizenship and Sustainability Education (including the themes of education for
 peace, human rights, gender equality and cultural diversity).
- Gaining international recognition for the interwoven strategies mainstreaming Education for Sustainable Development in schools through curricular (*UNAA Global Citizenship and Sustainability Program*) and extracurricular (annual *UNAA Global Goals Challenge*) programs. This included winning approximately \$8 000 for UNAAWA through the *Global Challenges Foundation* (Sweden) and achieving the highest level of recognition (*Outstanding Flagship Project*) through the UN University Regional Centre of Expertise Hub (Japan).
- Maintaining interactions with member schools in the face of the significant COVID-19 disruptions.
- Hosting 12 like-minded organisations and an audience of approximately 200 adults and children at the 2019 Partners in Peace Fair and Ceremony (International Day of Peace, Fremantle Town Hall).

"I have absolutely loved teaching the UNAA Global Citizenship Program with my Year 12 class. I look forward to the class each week, as the students are actively engaged in meaningful learning where they are examining real-life issues and creating their own solutions that they can implement on a local/regional/global level. Students develop a deep understanding of the UN and SDGs and are able to connect them to their own community. Project based learning has enhanced students' enterprise skills as they collaborate with others to look at problems with critical and creative thinking skills to come up with possible solutions. This leads to the innovation of new products, designs and ideas. What I have loved the most is to see the development of self-confidence and a sense of empowerment within the students. They have taken ownership of not only their projects but also their curiosity and love of learning and realize that they have the power to make a difference." **Michele Watson, Manea Senior College**





Priorities for the future development of the UNAAWA school programs:

- Completing the new UNAAWA school programs website linked to the main UNAAWA website.
- Improving procedures for monitoring and managing school membership renewals.
- Developing online learning versions of UNAAWA school programs, particularly Kindergarten to Year 12 *Global Citizenship and Sustainability* curriculum packages developing student agency and global competence as defined by the *UNESCO Framework for Global Citizenship Education* and the OECD.
- Exploring the potential for integration and synergy with other SDG based school programs including Young Person's Plan for the Planet, Curtin University Balance of the Planet and STEM4Innovation.

ENVIRONMENT COMMITTEE













The year began with Dr Marianne Dahle stepping down as Chair and the committee's Vice-Chair, Amanda Elizabeth moving into the position, with Dr Sonja Kuzich taking the role of Vice-Chair. With the restructuring of the committee also came a refocusing of our goals. We decided to encourage younger members, that were at the beginning of their careers, to join the committee. We did this by creating positions such as 'Youth Representative' and 'Communications Support'. The advantages of this were two-fold; it gave us an opportunity to form mentor-like relationships as well as have a stronger reach with younger audiences.

This first half of the year was spent managing the Covid situation and the transition to online events, the second half would seem much stronger for the Environment Committee with four events planned. Our first event for the year was the 'Children: Mind, Well-Being and Nature', organised by Dr Sonja Kuzich in conjunction with Curtain University. The conference discussed the impact nature has on the mental and physical health of children; a topic more pertinent than ever. With more than 120 registered participants, there is the potential for this to become an annual event for the committee.

With this in mind, we have also committed to ensuring a balance between corporate style events and events where we are outside, amongst the environment. This will allow us, and our members, to have positive, tangible effects on the environment, such as cleaning beaches and planting trees. With the weather warming and Covid restrictions easing this can now be achieved.

A major focus for the committee this year has been partnerships. By partnering with other like-minded organisations, we will gain further reach in both promoting the work of the UN and the UNAAAWA. Amanda set up a meeting with Zonta to discuss the opportunity of an organisational partnership, which is currently in discussion (with all parties positive to the idea). On a committee level, we have had discussions with GreenBatch, Reflections and the YMCA, all of which have agreed to partnering in the future.

HUMAN RIGHTS COMMITTEE





The Human Rights Committee with its present members commenced its work as of August 2020. The newly formed committee are made up of passionate individuals from Indigenous, Nigerian, Malaysian Indian, Singaporean Chinese, Filipino/Czech and French backgrounds.

Achievements over the past year:

- The President of UNAAWA was invited by our community partner, Museum of Freedom & Tolerance, and the US Consulate to jointed support the Universal Declaration of Human Rights (UDHR) Day event n early December 2019. The event highlighted the plight of the Uyghur people in Western China.
- The previous committee put together "The Art of Storytelling' Exhibition" at the Western Australian Shipwrecks Museum between late December 2019 to early March 2020
- In August and September 2020, The Committee selected 4 judges for the UN Day Human Rights Awards and submitted a total of 6 nominations for the Human Rights awards.
- Committee members, several members of the Human Rights award judging panel, including Indigenous representatives, supported and attended the UNAAWA Networking for Change Sundowner event at the Duxton Hotel on 8 September 2020, bringing awareness to the cause of suicide prevention.

Looking ahead: 2020-2021

With a fresh insight into relevant issues, the committee brings forward a new vision into the possibilities for the future:

- The Committee will be participating at the **75**th **anniversary UN Day** on 23rd October, brining awareness the importance of Human Rights to ensure that no one is left behind in the recovery from the COVID19 crisis.
- Winners of the Human Rights Awards on the UN Day will be featured and filmed so that champions could be promoted to regional parts of Australia via digital means.
- We will be supporting the Reconciliation Action Working Group to launch an event at next year's **United Nations Declaration on the Rights of the Indigenous People** in 2021. The objective is to promote Australia's commitment to improving the lives of our Indigenous peoples here in WA. UNAA YOUNG PROFESSIONALS REPORT



2019 UNAA Young Professionals WA Excellence Award

The 2019 UNAA Young Professionals (WA) Award is dedicated to the UN Sustainable Development Goals (SDGs), that aim to achieve a better and more sustainable future for all. They address the global challenges that we face, including those related to poverty, inequality, climate, environmental degradation, prosperity, peace and justice.

JUNE 2020 - WORLD CAFÉ SERIES

On the 9th of June 2020, the UNAA WA YP's held a virtual event via Zoom called the 'World Cafe Series'. This first virtual event explored the impacts and opportunities created by COVID-19.

The format of the event was a panel discussion moderated by UNAA WA YP President, Neesha Seth. The panellists were a diverse group of business and community leaders from across the world including Michael Sheldrick, Chief Policy Officer at Global Citizen; Dr Zarra Torre, Chief Executive Officer at The Difference; Tom Goerke, lead for Cisco's Australian Innovation Centres; and Ayden Doohan, Hospital Project Lead for St John of God Healthcare. The panel discussion explored a number of issues covering the personal, community, and business impacts of the global COVID-19 pandemic.

The second part of the event commenced at the conclusion of the panel discussion and allowed the audience to get a little more involved in the discussion process. During the ticket purchase process, we asked which SDG most resonated with that attendee. We used this data to assign attendees into breakout rooms on Zoom to further discuss that particular SDG in small groups where everyone had the opportunity to voice their opinions and experiences. Each of these breakout rooms was moderated by a mentor chosen by the UNAA WA YP committee based on their alignment with each SDG. The main purpose of the breakout rooms was to discuss the ways in which we can all operationalise the Sustainable Development Goals (SDG's) during COVID-19.

Overall, the UNAA WA YP team were happy with the overall attendance with 78 attendees plus mentors and panellists. Feedback from the event was largely positive with attendees interested in attending more events of a similar nature. To improve the next event of this nature, we would recommend reducing the amount of time allocated to the panel discussion portion of the event and increasing the time allocated to the breakout rooms to give attendees more opportunity to dive deeper into the SDG discussion.

SDG BUSINESS FORUM SERIES COMMITTEE

The UNAAWA held two SDG Business Forums for the year 2020 on 26 February and 5 August. One was titled "Achieving SDGs and Impact on Business Transformation", sponsored and hosted at Ernst & Young Perth, the other digitally on the topic of "Accelerating Innovation & SDGs – Post-COVID Recovery for WA". Both events were well-attended by members, professionals and stakeholders in the business and public sectors. Due to the crisis, only the first event was conducted in-person and it helped generated funds. The second event was decidedly made complimentary to viewers online for the benefit of the community in Perth and regional business communities.

Both panel discussions were led by the Founder of the forum series and President of UNAAWA, Dr Sandy Chong. Speakers for the first forum included: Michele Villa (Founder of NexStep), Jessica Shaw (MLA of Swan Hills) and Adam Carrel (Partner of EY Perth). The second digital forum had Dr Marcus Tan (Founder, CEO and Medical Director at HealthEngine), Cettina Raccuia (Capability Manager for RAC WA), and Elizabeth Brennan (Non-executive Director for Wide Open Agriculture).

The speakers talked about the necessity of bringing changes into the current ways of doing business and the challenges that they need to overcome to achieve sustainability. Despite the advanced technology, the speakers pointed out that businesses need more innovative ideas, strong leadership, and enduring risk-taking ability – an approach which the non-profit sector could also adopt in order to survive and fast-changing environment. Businesses could also set great corporate citizenship example by standing up against norms that do more harm than good for the communities and environment one operates in.

From the UNAAWA Global Representative

The previous year has been a difficult period both in Australia and Overseas. The United Nations and all it agencies have never been under so much global scrutiny, embracing international concern of sovereign military, political global power, Indo-China disagreements so close to our Australian homeland are indeed worrying to our security.

The further continuing concerns of environmental compliance, peace, trade, human rights alignments, military conflicts continue to rage mainly in the country's experiences with severe poverty and child labour. 
TREASURER'S REPORT

Treasurer's report for the year ended 30 June 2020

I, Camille Doucet being the Treasurer of the United Nations Association of Australia WA Division Inc., certify that:

The statements attached to this annual report give a true and fair view of the financial position and performance of the United Nations Association of Australia WA Division Inc. during and at the end of the financial year of the association ending on 30 June 2020.

As shown in the graph below, the Associations' net revenue per quarter has dramatically decreased in the third and fourth quarters of the year. The net revenue generated from the first and second quarters account for 88% of the total net revenue for the year. This decline is mostly attributable to the cancellation of physical events to comply with governmental restrictions and ensure the good health and safety for all.



Anticipating the decline in revenue from fundraising streams, it was decided to terminate the office lease with the Claisebrook Lotteries House Association (CLHA). The CLHA has graciously agreed to terminate the lease without imposing any penalties for early termination. By digitalising the Association's office, the estimated yearly savings are of approximately \$4,000, which account for roughly 40% of the Association's total yearly operating costs. Another way to mitigate this challenge has been to obtain financial support from Lotterywest to assist the Association in covering its operating costs. A grant of \$7,450 was received in June 2020.

Despite the challenges that the Association has faced throughout the year, the financial situation of the organisation is healthy and adequate for its current needs.

RSM Australia Partners have agreed to audit the accounts of the Association for the year ended 30 June 2020, pro-bono. The audit work is scheduled to commence in November 2020. It is planned to place the audited financial report on the Association's website upon conclusion of the audit.
